Subject: Review of NCCMIS at the state level.

Dear Madam / Sir,

You must be aware that National Cold Chain Management Information System (NCCMIS) developed by Ministry of Health and Family Welfare (MoHFW) for monitoring the real time performance of cold chain equipment and managing the inventory. The NCCMIS software is being maintained and monitored by National Cold Chain and Vaccine Management Resource Center (NCCVMRC) in NIHFV.

NCCMIS helps in taking policy decisions, planning and allocation of cold chain equipments at National level. Hence, regular updation of software is of utmost importance. In this context a series of National training of trainers (ToT) were conducted in NIHFV during 2012 and 2013 and subsequently the states were requested to conduct the training for the state and district officials in a cascade manner.

In this regard two days review cum hands on training may be conducted by the states/UTs. The objective of the review is to ensure the data completeness, correctness in the NCCMIS, usage and feedback for improvisation from the end users and hands on refresher training.

The states supported by GAVI-HSS (Assam, UP, Bihar, MP, Rajasthan, Gujarat, Chhattisgarh, Jharkhand, Odisha, Nagaland, Manipur, and Arunachal Pradesh) have funds under GAVI assistance to conduct the review of NCCMIS at their respective states. Other states can use the funds under immunization review/training to conduct the review and hands-on training. In this context please refer to the letter of even number dated 25th August 2014. Copy of the letter is attached.

In view of that you are requested to inform the National Cold Chain and Vaccine Management resource Center (NCCVMRC) in NIHFV about the dates to hold such two day workshop so that the officials from the NCCVMRC can attend and support the states in conducting the workshop. The batch size may be kept at 40 number of participants with two from each district (*out of the two at least one should be having computer knowledge and responsible for updating the NCCMIS*) for better communication with the participants. These activities may be planned to be completed by 31st December 2014.
